Know all by these present, that the undersigned hereby makes, constitutes and appoints Laurence J.N. Cooper, Kevin G. Lafond and Marc Recht as the undersigned's true and lawful attorney-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned to:
